Since our trips in April, 2022, we have been in contact with some leaders there. No Deaf people were affected by Hurricane Fiona, though the communities were underwater. Our Deaf church in San Juan was okay, PTL! However, our Mountain evangelist named Victor Martiez from Aibonito was seriously ill and was admitted into an emergency hospital. We prayed and thank God he is back home now recovering from diabetes. To God be the glory. Please continue to pray for him and his wife. We plan to be back to PR in April or early May 2023.

### **DCEA Nigeria, Africa**

In September, 2022, we bought about 3/4 acre of land in the heart of the town for the Deaf Christian Training Center to train, teach, mentor and spread the Good News to Deaf youths throughout Africa.
